

## Report of the Fifth Committee

## I. Introduction

- 1. At its 2nd plenary meeting, on 17 September 2021, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-sixth session the item entitled "Programme budget for 2021" and to allocate it to the Fifth Committee.
- 2. During the first part of the resumed seventy-sixth session, the Fifth Committee met formally and remotely owing to the coronavirus disease (COVID-19) pandemic, during which it considered the item. The Committee formally considered the item in person at its 10th and 12th meetings, on 4 March and 31 March 2022. Statements and observations made in the course of the Committee's formal consideration of the item are reflected in the relevant summary records.<sup>1</sup>
