I. INTRODUCTION

- 1. At the 1st plenary meeting of the fifteenth special session, on 31 May 1988, the General Assembly decided to establish an ad hoc committee and designated it the Committee of the Whole of the Fifteenth Special Session, with a Chairman, 18 Vice-Chairmen and a Rapporteur, on the understanding that its Chairman would also be a member of the General Committee.
- 2. At the same meeting, the General Assembly unanimously elected Mr. Mansur Ahmad (Pakistan), Chairman of the Preparatory Committee for the third special session of the General Assembly devoted to disarmament, as Chairman of the Committee of the Whole.
- 3. At the same meeting, the General Assembly adopted the agenda of the fifteenth special session (A/S-15/15). It was also decided that items 1 to 9 and 16 would be considered directly in plenary meeting and items 10 to 15 would be allocated to the Committee of the Whole.
- 4. At the same meeting, the General Assembly endorsed the report of the Preparatory Committee for the Third Special Session of the General Assembly Devoted to Disarmament (A/S-15/1) 1/ as well as the proposal of the Chairman of the Preparatory Committee that the work of the Committee of the Whole would be advanced from 6 to 3 June.
- 5. The general debate, which took place in plenary meeting from 1 to 14 June, included consideration of agenda item 9.
- 6. In the course of the general debate, 23 heads of State or Government, 1 Vice-President, 6 Deputy Prime Ministers and 61 Ministers of Foreign Affairs and other heads of delegations addressed the special session.
- 7. Several heads of State or Government sent messages to the session. In the course of the general debate, representatives of the non-member States of the Democratic People's Republic of Korea, the Holy See, the Republic of Korea and Switzerland, as well as the Director General of the International Atomic Energy Agency also made statements. In addition, representatives of the League of Arab States and the Organization of the Islamic Conference, as well as of the Palestine Liberation Organization and the South West Africa People's Organization, addressed the Assembly during the general debate.
- 8. At its 1st meeting, on 3 June 1988, the Committee of the Whole unanimously elected the following officers:
- (a) <u>Vice-Chairmen</u>: The representatives of the following delegations: Argentina, Australia, Bahamas, Czechoslovakia, Hungary, Japan, Mongolia, Morocco,

Netherlands, New Zealand, Norway, Romania, Sri Lanka, Sudan, Togo, Uruguay, Yugoslavia and Zaire.

- (b) Rapporteur: Mr. Pedro Nuñez-Mosquera (Cuba).
- 9. At the same meeting, the Committee decided to establish three working groups as follows: Working Group I to deal with agenda item 10 and to be chaired by Mr. Davidson L. Hepburn (Bahamas); Working Group II to deal with agenda items 12 and 15 and to be chaired by Mr. Paul-Joachim von Stülpnagel (Federal Republic of Germany); Working Group III to deal with agenda items 13 and 14 and to be chaired by Mr. Paul Bamela Engo (Cameroon). The Committee of the Whole authorized the Chairman to request Mr. Alfonso García Robles (Mexico) to conduct consultations on agenda item 11, as appropriate, and thereafter to report to the Committee of the Whole.
- 10. In the course of the 1st and 2nd meetings, on 3 and 6 June, the Committee of the Whole considered the reports of the Conference on Disarmament (A/S-15/2); $\underline{2}$ / the Ad Hoc Committee on the World Disarmament Conference (A/S-15/4); $\underline{3}$ / the Ad Hoc Committee on the Indian Ocean (A/S-15/5); $\underline{4}$ / and the Disarmament Commission (A/S-15/3). 5/
- 11. At its 2nd meeting, the Committee of the Whole heard a statement by the Secretary-General of the Agency for the Prohibition of Nuclear Weapons in Latin America (OPANAL).
- 12. At its 3rd to 6th meetings, on 8 and 9 June, the Committee heard statements by representatives of non-governmental organizations and peace and disarmament research institutes (see annex II).
- 13. At its 8th meeting, on 20 June, the Committee of the Whole decided that the deadline for submission of any further proposals would be 22 June.

II. WORK OF THE COMMITTEE OF THE WHOLE

A. Consideration of agenda item 10

B. Consideration of agenda item 11

19. As agreed by the Committee of the Whole (see para. 9 above), the Chairman of the Committee of the Whole requested Mr. Alfonso García Robles (Mexico) to conduct considerations regarding agenda item 11 entitled "Consideration and Adoption of the Comprehensive Programme of Disarmament". At the 8th meeting of the Committee of the Whole, on 20 June, Mr. García Robles reported on the results of his consultations (A/S-15/AC.1/PV.8).

C. Consideration of agenda items 12 and 15

- 20. Working Group II was established by the Committee of the Whole (see para. 9 above) to deal with agenda item 12 entitled "Assessment of developments and trends, including qualitative and quantitative aspects, relevant to the disarmament process, with a view to the elaboration of appropriate concrete and practical measures and, if necessary, additional principles, taking duly into account the principles and priorities established in the Final Document of the Tenth Special Session of the General Assembly, the first special session devoted to disarmament"; and agenda item 15 entitled "Relationship between disarmament and development, in the light of the action programme adopted at the International Conference".
- 21. The Working Group held 11 meetings between 6 and 17 June 1988.
- 22. At its 7th meeting, on 13 June, the Committee of the Whole received a progress report on the work of the Working Group from its Chairman, Mr. Paul-Joachim von Stülpnagel (Federal Republic of Germany).
- 23. At its 8th meeting, on 20 June, the Committee of the Whole took note of the report of the Working Group, as contained in document A/S-15/AC.1/19 and Add.1-3.

D. Consideration of agenda items 13 and 14

- 24. Working Group III was established by the Committee of the Whole (see para. 9 above) to deal with agenda item 13 entitled "Consideration of the role of the United Nations in the field of disarmament and of the effectiveness of the disarmament machinery"; and agenda item 14 entitled: "United Nations information and educational activities in the field of disarmament, including measures to mobilize world public opinion in favour of disarmament:
 - (a) World Disarmament Campaign;
 - (b) Other public information activities".
- 25. The Working Group held 12 meetings between 7 and 17 June 1988. During that period, the Chairman also conducted informal consultations.
- 26. At its 7th meeting, on 13 June, the Committee of the Whole received a progress report on the work of the Working Group from its Chairman, Mr. Paul Bamela Engo (Cameroon).
- 27. At its 8th meeting, on 20 June, the Committee of the Whole took note of the report of the Working Group contained in document A/S-15/AC.1/20 and Corr.1. A report of the Chairman of the Working Group as contained in document A/S-15/AC.1/21 was also presented.
