Chapter I

Matters calling for action by the Economic and Social Council or brought to its attention

A. Draft decisions for adoption by the Economic and Social Council

1. The Commission on Narcotic Drugs recommends to the Economic and Social Council the adoption of the following draft decision:

Draft decision

Report of the Commission on Narcotic Drugs on its reconvened fifty-third session and provisional agenda for its fifty-fourth session

The Economic and Social Council:

- (a) Takes note of the report of the Commission on Narcotic Drugs on its reconvened fifty-third session;
- (b) Further to its decision 2010/244, approves the provisional agenda for the fifty-fourth session of the Commission, as set out below.

Provisional agenda for the fifty-fourth session of the Commission on Narcotic Drugs

- 2. Adoption of the agenda and other organizational matters.

 - (a) Demand reduction and related measures;
 - (b) Supply reduction and related measures;
 - (c) Countering money-laundering and promoting judicial cooperation to enhance international cooperation.

B. Matters brought to the attention of the Economic and Social Council

2. The attention of the Economic and Social Council is drawn to the following resolution adopted by the Commission on Narcotic Drugs at its reconvened fifty-third session.

Resolution 53/16

Streamlining of the annual report questionnaire

The Commission on Narcotic Drugs,

Bearing in mind the provisions of the Single Convention on Narcotic Drugs of 1961,¹ that Convention as amended by the 1972 Protocol,² the Convention on Psychotropic Substances of 1971³ and the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances of 1988,⁴

Recalling its resolution 42/11 of 1 December 1999, in which it adopted a unified single questionnaire that included the information required on all action plans and measures adopted by the General Assembly at its twentieth special session.

Recalling also its resolution 43/1 of 15 March 2000, in which it decided to abolish sections 2 and 3 of part II of the annual report questionnaire and requested the Executive Director to revise section 1 of part II of the questionnaire,

Recalling further its resolution 44/3 of 29 March 2001, in which it decided to replace the existing part II of the annual report questionnaire with the revised part II of the questionnaire,

Aware of the need to establish adequate procedures to fulfil the mandates assigned to it with regard to the examination of reports submitted in accordance with the above-mentioned treaties,

Bearing in mind the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem,⁵ adopted during the high-level segment of the fifty-second session of the Commission, in which Member States took account of the need for indicators and instruments for the collection and analysis of accurate, reliable and comparable data on all relevant aspects of the world drug problem and, where appropriate, the enhancement or development of new indicators and instruments,

Bearing in mind also that in the Political Declaration and Plan of Action, Member States committed themselves to report to the Commission on their efforts to fully implement the Political Declaration and Plan of Action,

Recalling its resolution 52/12 of 20 March 2009 and its decision 53/2 of 10 March 2010, in which it decided to convene an open-ended expert group on data collection to improve the collection, reporting and analysis of data to monitor the implementation of the Political Declaration and Plan of Action, which held two meetings,

Noting with appreciation the efforts of the open-ended expert group to improve the collection, reporting and analysis of data to monitor the implementation

of the Political Declaration and Plan of Action, as well as the reporting mandated by the three international drug control treaties,

- 1. Decides to adopt the annual report questionnaire⁶ as submitted by the expert group on data collection;
- 2. Also decides that the annual report questionnaire should be periodically reviewed in order to have a flexible international instrument allowing the reporting of national and emerging drug situations, taking into account the needs and challenges of balancing the collection of qualitative and quantitative data and information, and requests the United Nations Office on Drugs and Crime to carry out such reviews, taking into consideration, among other things, the challenges identified and the recommendations made by the reconvened expert group on data collection, including the need to simplify the annual report questionnaire, taking into account the different levels of reporting capacity of Member States;⁷
- 3. Requests the United Nations Office on Drugs and Crime to assist, upon request, Member States in developing their data-collection and reporting capacities;
- 4. Requests all Member States to comply with the reporting mandates of the Single Convention on Narcotic Drugs of 1961,8 that Convention as amended by the 1972 Protocol,9 the Convention on Psychotropic Substances of 1971¹⁰ and the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances of 1988,¹¹ and the Political Declaration on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem¹² and provide on a yearly basis the necessary data by completing the annual report questionnaire;
- 5. Also requests Member States to return the duly completed questionnaire by 30 June of each year to enable the Secretariat to make a meaningful analysis of the drug control situation and report to the Commission;
- 6. *Requests* the Executive Director to continue to submit to the Commission the annual reports on trends in global drug abuse and the illicit supply of drugs;
- 7. Also requests the Executive Director to prepare and submit to the Commission, on a biennial basis, on the basis of the responses provided by Member States to the questionnaire, a single report on action taken to implement the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem, the first of which should be examined by the Commission at its fifty-fifth session, in 2012.

Chapter II

Improving the collection, reporting and analysis of data to monitor the implementation of the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem

- 3. The Commission considered item 5 of its agenda, entitled "Improving the collection, reporting and analysis of data to monitor the implementation of the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem", at its 11th meeting, on 2 December 2010. For its consideration of the item, the Commission had before it the following:
- (a) Annual report questionnaire: Part One. Legislative and institutional framework (E/CN.7/2010/19);
- (b) Annual report questionnaire: Part Two. Comprehensive approach to drug demand and supply reduction (E/CN.7/2010/20);
- (c) Annual report questionnaire: Part Three. Extent and patterns of and trends in drug use (E/CN.7/2010/21);
- (d) Annual report questionnaire: Part Four. Extent and patterns of and trends in drug crop cultivation and drug manufacture and trafficking (E/CN.7/2010/22);
- (e) Note by the Secretariat transmitting the report on the meeting of the reconvened expert group on data collection (E/CN.7/2010/24);
- (f) Report on the meeting of the expert group on data collection held in Vienna from 11 to 13 October 2010 (UNODC/CND/EG.1/2010/14).
- 4. A statement was made by the observer for Mexico in his capacity as Chair of the expert group on data collection. Statements were made by the representatives of Argentina, the Bolivarian Republic of Venezuela, Belgium (on behalf of the European Union), China, Australia, the Russian Federation, Japan, the United States of America and the Plurinational State of Bolivia. The observer for Zimbabwe also made a statement. A representative of the Secretariat made a statement.

A. Deliberations

5. Several speakers expressed satisfaction with the results achieved by the expert group on data collection and commended the work of its Chair, Ulises Canchola of Mexico. They welcomed the consensus reached on a revised instrument that would allow the reporting by Member States of drug-related data and on the implementation of the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem, adopted at the high-level segment of the fifty-second session of the Commission.

- 6. Several speakers supported the recommendations of the expert group regarding the importance of reporting quantifiable, objective and measurable data and the need to periodically review and update the annual report questionnaire through an appropriate mechanism, which would be a matter for the consideration of the Commission in due course.
- 7. Several speakers underlined the need to exchange best practices and strengthen the data-collection and reporting capacities of Member States, including through the provision of technical assistance by the United Nations Office on Drugs and Crime (UNODC). One speaker noted that UNODC should also raise awareness among Member States of the importance of collecting drug-related data.

B. Action taken by the Commission

8. At its 11th meeting, on 2 December 2010, the Commission adopted a draft resolution submitted by the Chairman, as orally revised, entitled "Streamlining of the annual report questionnaire" (E/CN.7/2010/L.22). (For the text, see chap. I, sect. B, resolution 53/16.) The following delegations expressed support for the resolution: Australia, Brazil, Chile, Germany, Indonesia, Mexico, the Philippines, the United States, Venezuela (Bolivarian Republic of) and Zimbabwe. Prior to the adoption of the draft resolution, a representative of the Secretariat read out a financial statement, the text of which is contained in annex I to the present report.

Chapter III

Policy directives to the drug programme of the United Nations Office on Drugs and Crime and strengthening the drug programme and the role of the Commission on Narcotic Drugs as its governing body, including administrative, budgetary and strategic management questions

- 9. At its 11th meeting, on 2 December 2010, the Commission considered item 10 of its agenda, entitled "Policy directives to the drug programme of the United Nations Office on Drugs and Crime and strengthening the drug programme and the role of the Commission on Narcotic Drugs as its governing body, including administrative, budgetary and strategic management questions". For its consideration of the item, the Commission had before it the following:
- (a) Financial report and audited financial statements for the biennium ended 31 December 2009 and report of the Board of Auditors (A/65/5/Add.9);
- (b) Note by the Secretariat on the work of the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime (E/CN.7/2010/23-E/CN.15/2010/21);
- (c) Note by the co-chairs of the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime (E/CN.7/2010/CRP.9-E/CN.15/2010/CRP.7).
- 10. The representative of Spain, in his capacity as co-chair of the standing openended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime, made a statement. A representative of the Secretariat also made a statement. The representatives of Belgium (on behalf of the European Union), Argentina, China, Brazil, the United States and the Russian Federation also made statements. Statements were also made by the observers for Sweden, Mexico, Guatemala and Zimbabwe.

A. Deliberations

11. The representative of Spain, speaking in his capacity as co-chair of the standing open-ended intergovernmental working group on improving the governance and financial situation of UNODC, presented a summary of the work of the working group, indicating that participation had been active and there had been many fruitful and focused discussions. He also read out a statement on the outcome of the most recent discussions, which could not be included in the note by the Secretariat on the work of the working group, and invited the Commission to take note of that statement, which would be reflected in the report on the reconvened fifty-third session.

- 12. Several speakers considered that the financial status quo was not satisfactory, specifically in view of the disappointing financial situation of the Office reported by the Executive Director.
- 13. Several speakers reiterated that it was necessary for the working group to continue its work, taking into account the concerns and expectations expressed during the meeting of the Commission, aimed at the preparation of tangible and practical recommendations for the consideration of the Commission at its next session to enhance the financial situation in all its aspects.
- 14. Several speakers commended the work done by the working group and stated that they looked forward to the continuation of its work.
- 15. A number of speakers noted that, while the working group had started to deal with the issues the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice had entrusted to it, much remained to be done, and noted that no recommendations had yet been put forward by the working group for consideration by the Commissions.
- 16. Several speakers stressed that the working group had been an important forum for dialogue among Member States, and between them and the Secretariat, particularly as regards the development of thematic and regional programmes and the re-establishment of an independent evaluation function within the Office.
- 17. Some speakers underlined the need to join forces to increase the share of general-purpose and regular budget funds available to the Office in order to resolve its financial situation.
- 18. Several speakers indicated their wish that the working group become a permanent body of the Commission. In this regard, one delegation expressed the view that it was important to maintain the informal nature of the working group. It was also noted that all Member States should share equally the burden of providing funding to cover programme support costs.
- 19. Commenting on the other interventions, a representative of the Secretariat stated that the working group had been an important venue for discussion, inter alia, of regional and thematic programmes and evaluation and that it should also address the financial situation of the Office. In this regard, he noted that UNODC would have to undertake additional cost-saving measures unless some action were taken by the governing bodies. Such action could include the consideration of the allocation of an indicative volume of general-purpose contributions to support the essential infrastructure required to enable the Office to deliver a growing programme of work.

B. Action taken by the Commission

20. At its 11th meeting, on 2 December 2010, the Commission took note of the statement made by the co-chair of the standing open-ended intergovernmental working group on improving the governance and financial situation of the UNODC (see annex II).

Chapter IV

Other business

- 21. At its 12th meeting, on 2 December, the Commission considered agenda item 12, entitled "Other business". The Chair introduced the item and informed the Commission about the revised provisional agenda for its fifty-fourth session, which had been considered at the meetings of the extended Bureau on 26 November and 2 December 2010.
- 22. The Chairman of the Commission made a statement. The representatives of Chile, Argentina, Peru and Colombia made statements. The observer for Mexico also made a statement. A representative of the Secretariat also made a statement.

A. Deliberations

1. Duration of the fifty-fourth session and other arrangements

23. The Chairman apprised the Commission of the discussion at the meeting of the extended Bureau held on 17 June 2010, through which it had been established that the fifty-fourth session of the Commission would have a duration of five days, from Monday, 21 March to Friday, 25 March 2011, preceded by informal consultations on Friday, 18 March 2011. The Commission was also informed that the reconvened fifty-fourth session of the Commission would be held on 12 December 2011.

2. Meeting of the Chairman with the President of the International Narcotics Control Board and a delegation of the World Health Organization

The Chairman informed the Commission of a meeting he had been invited to attend on 11 November 2010 with the President of the International Narcotics Control Board and a delegation of the World Health Organization (WHO). At that meeting, the functions mandated to WHO under the 1961 and 1971 Conventions to provide technical recommendations to the Commission with regard to the scheduling of narcotic drugs and psychotropic substances, and the functioning of the Expert Committee on Drug Dependence, established by WHO to assist it in conducting the scientific and medical review of substances being considered for scheduling, and recommendations thereof to the Commission, were discussed. It was noted that the Expert Committee had not met since 2006 and that a number of issues that the Commission had brought to the attention of WHO in a number of its resolutions were still pending, which impeded the Commission from fulfilling its functions under the 1961 and 1971 Conventions. The delegation of WHO noted that the Expert Committee had not met since 2006 owing to budgetary constraints faced by WHO; in this regard, WHO sought the support of the Commission. The Chairman had informed the delegation of WHO of the Commission's high regard for WHO and the importance the Commission attached to the technical advice of WHO and to ensuring the impartiality and independence of its advice in this regard. He urged WHO to investigate all possible mechanisms to ensure that resources were made available within its regular programme of work to enable it to fulfil its mandate under the 1961 and 1971 Conventions. The Chairman brought the matter to

the attention of the Commission, as he had undertaken to do so and as it would be of relevance to the preparation of the fifty-fourth session of the Commission.

3. Other matters

25. One representative requested that the conference room paper that had been made available to the Commission at its reconvened fifty-third session (E/CN.7/2010/CRP.9-E/CN.15/2010/CRP.7) also be distributed at the fifty-fourth session, under item 3 (b) of the provisional agenda. The Commission took note of the request.

B. Action taken by the Commission

26. At its 12th meeting, on 2 December 2010, the Commission approved for adoption by the Economic and Social Council a draft decision, as orally amended by the Chairman, as recommended by the extended Bureau at its meeting held on 2 December 2010, entitled "Report of the Commission on Narcotic Drugs on its reconvened fifty-third session and provisional agenda for its fifty-fourth session" (E/CN.7/2010/L.21). (For the text, see chap. I, sect. A, draft decision.) Following the approval of the draft decision, the representative of Chile reiterated her delegation's support for the revised provisional agenda and stated that there was a need for an operational document containing recommendations stemming from the discussion under items 6 (a) to (c) of the provisional agenda for the fifty-fourth session. The representatives of Argentina, Peru and Colombia and the observer for Mexico associated themselves with the statement.

Chapter V

Adoption of the report of the Commission on its reconvened fifty-third session

27. At its 12th meeting, on 2 December 2010, the Commission adopted the section of the draft report relating to item 10 of the agenda, which had been made available in English only, as orally amended, and decided to entrust the finalization of the report to the Rapporteur and the Chairman of the Commission at its fifty-third session, in consultation with the Chair and the Rapporteur of the Commission at its fifty-fourth session, as required.

Chapter VI

Organization of the session and administrative matters

A. Opening and duration of the session

- 28. The Commission on Narcotic Drugs held its reconvened fifty-third session in Vienna on 2 December 2010. During the reconvened fifty-third session of the Commission, the extended Bureau held one meeting to consider matters related to the organization of work.
- 29. At the 11th meeting, on 2 December, the Executive Director of UNODC made an opening statement. Statements were also made by the observers for Guatemala (on behalf of the Group of 77 and China) and Burkina Faso (on behalf of the Group of African States) and the representative of Chile (on behalf of the Group of Latin American and Caribbean States).

B. Attendance

30. The session was attended by representatives of 37 States members of the Commission (16 were not represented). Observers for other States Members of the United Nations, organizations of the United Nations system and intergovernmental and non-governmental organizations also attended. A list of participants is contained in document E/CN.7/2010/INF.1/Add.1.

C. Documentation

31. The documents before the Commission at its reconvened fifty-third session are listed in annex III to the present report.

D. Closure of the reconvened fifty-third session

32. At the 12th meeting, on 2 December, a closing statement was made by the Chairman of the Commission.

Annex I

Financial statement on the draft resolution entitled "Streamlining of the annual report questionnaire"*

- 1. The present statement was prepared in accordance with rule 28 of the rules of procedure of the functional commissions of the Economic and Social Council.
- 2. By operative paragraph 3 of draft resolution E/CN.7/2010/L.22, the Commission on Narcotic Drugs would request the United Nations Office on Drugs and Crime to assist, upon request, Member States in developing their data-collection and reporting capacities.
- 3. Should the Commission adopt draft resolution E/CN.7/2010/L.22, it is envisaged that extrabudgetary resources in the amount of \$3,503,000 would be required over five years to provide the requested assistance in developing data-collection capacities. The level of resource requirements would provide for a programme manager at the P-4 level, travel of staff, annual expert group meetings, training on data collection, including the development of training modules and methodology guides, and support in data collection in selected regions and countries.
- 4. Hence, the adoption of draft resolution E/CN.7/2010/L.22 would not entail any additional appropriation under the programme budget for the biennium 2010-2011.

Annex II

Statement by the co-chairs of the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime

- 1. Following the informal meeting of the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime on 29 October 2010,^a the co-chairs convened an informal meeting of the working group, on 25 November, and two rounds of "informal informals", on 26 and 30 November 2010. At those meetings, participants considered a working paper that had been introduced at the meeting held on 25 November 2010. After deliberations, the co-chairs submitted the following statement for the consideration of the Commission on Narcotic Drugs at its reconvened fifty-third session and the Commission on Crime Prevention and Criminal Justice at its reconvened nineteenth session.
- 2. In accordance with the mandate set out in Commission on Narcotic Drugs resolution 52/13 and Commission on Crime Prevention and Criminal Justice resolution 18/3, the working group examined ways and means of ensuring support for and adequate follow-up of the development of the programmes of the Office, including thematic and regional programmes, and improving the governing role and functioning of the Commissions.
- 3. Several points were discussed at the above-mentioned meetings, including:
- (a) The importance for thematic and regional programmes to include, inter alia, main objectives and features; their relation to the strategy for the period 2008-2011b and the Strategic Framework of the Office; and an estimate of the costs of their implementation and possible sources of financing, as appropriate;
- (b) The important role of the Independent Evaluation Unit in contributing to the evaluation and the development of thematic and regional programmes;
- (c) The relevance for the development of thematic and regional programmes of an equitable and consistent application of the standard programme support charge corresponding to extrabudgetary contributions;
- (d) Enhanced document preparation, briefings and increased dialogue continuing to have a significant positive effect on the governance of the United Nations Office on Drugs and Crime by the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice.
- 4. The working group recommends the continuation of its work in accordance with its mandate for the further consideration of the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice.
