Annotations

1. Election of officers

Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council stipulates that, at the commencement of the first meeting of a regular session, the Commission shall elect from among the representatives of its members a Chair, one or more Vice-Chairs and such other officers as may be required. Following the established practice, the Commission shall elect a Chair and four Vice-Chairs and also designate one of the Vice-Chairs as Rapporteur.

In subparagraph (c) of its decision 2002/210, the Economic and Social Council decided that, immediately following the closure of a regular session, the Commission for Social Development would hold the first meeting of its subsequent regular session for the sole purpose of electing the new Chair and other members of the Bureau. In its resolution 2010/10, the Council recommended that, to enhance the effectiveness of the work of the Commission, the officers elected to the Bureau serve for a term of office of two years, in parallel with the review and policy cycle.

Accordingly, the Commission held the first meeting of its fifty-second session on 15 February 2013, immediately following the closure of the fifty-first session, and elected by acclamation Sewa Lamsal Adhikari (Nepal) as Chair and Julia Thallinger (Austria), Larysa Belskaya (Belarus), Amira Fahmy (Egypt) and Carlos García González (El Salvador) as Vice-Chairs.

At the opening meeting of the fifty-second session, the Commission will designate one of its Vice-Chairs as having rapporteurial responsibilities.

2. Adoption of the agenda and other organizational matters

Rule 7 of the rules of procedure requires that, after the election of its officers at the beginning of each session, the Commission shall adopt the agenda for that session on the basis of the provisional agenda. The provisional agenda and documentation for the fifty-second session of the Commission were approved by the Economic and Social Council in its decision 2013/243.

The proposed organization of work of the Commission at its fifty-second session (see annex I) has been prepared pursuant to relevant decisions of the General Assembly and the Economic and Social Council to facilitate the consideration of agenda items within the time frame available and in accordance with the conference services allocated to the Commission. The timetable should be considered tentative and indicative: if the Commission completes its consideration of an item ahead of schedule, it may wish to proceed immediately to the next item.

The Commission is scheduled to meet from Tuesday, 11 February, to Friday, 21 February 2014. Arrangements have been made to hold morning and afternoon meetings during the session: morning meetings will be held from 10 a.m. to 1 p.m. and afternoon meetings from 3 p.m. to 6 p.m.

Future organization and methods of work of the Commission

In its resolution 2012/7 of 26 July 2012, the Economic and Social Council decided that the Commission should keep its methods of work under review and requested the Secretary-General to submit a report to the Commission at its fifty-first session on ways and means to strengthen its work, taking into account the views of Member States.

At the fifty-first session, in its decision 51/102 of 13 February 2013, the Commission took note of the report of the Secretary-General on the review of the methods of work of the Commission for Social Development (E/CN.5/2013/12) and decided to transmit it to the fifty-second session of the Commission.

In accordance with General Assembly resolution 55/46 on the implementation of the outcome of the World Summit for Social Development and of the twenty-fourth special session of the General Assembly entitled "World Summit for Social Development and beyond: achieving social development for all in a globalizing world", the Commission will undertake regular assessment of the implementation of the Copenhagen commitments and the further initiatives adopted at Geneva.

The Commission reviewed the theme at its fifty-first session in 2013 and will complete the biennial cycle by adopting action-oriented policy recommendations on promoting empowerment of people in achieving poverty eradication, social integration and full employment and decent work for all at its fifty-second session in 2013. The Commission will have before it the report of the Secretary-General on the priority theme.
