## Annex

### Report of the Security Council Committee established pursuant to resolution 1267 (1999)

On 16 January 2002, the Security Council adopted resolution 1390 (2002). In accordance with paragraph 6 of the resolution, all States are requested to report to the Committee, no later than 90 days from the date of adoption of resolution 1390 (2002), on the implementation of paragraph 2 of the resolution, in particular on the measures listed below that they have applied to all the individuals, groups, undertakings and entities associated with the Taliban and Al-Qaida included on the Committee's list:\*

- (a) freezing without delay any funds and other financial assets and economic resources;
- (b) preventing the entry into or transit through their territories;
- (c) preventing the direct or indirect supply, sale and transfer of all arms and related materiel, spare parts and technical advice, assistance or training related to military activities.
