Recommendations of the Analytical Support and Sanctions Monitoring Team contained in its twenty-fourth report

1. On 27 June 2019, the twenty-fourth report of the Analytical Support and Sanctions Monitoring Team ([S/2019/570](#)) was submitted to the Committee pursuant to paragraph (a) of annex I to Security Council resolution [2368 \(2017\)](#). A table of recommendations based on the report was also circulated to the Committee on 2 July 2019, and the Committee deliberated on the recommendations in informal consultations on 12 July 2019. The Committee would like to express its gratitude to the Monitoring Team for the exemplary work undertaken in the fulfilment of its mandate.
2. Since December 2005, when it established the practice, the Committee has responded to each of the reports submitted to it by the Monitoring Team and has brought to the attention of the Security Council and the public the Committee's position on the recommendations contained in those reports.

Position of the Committee on the recommendations contained in the twenty-fourth report of the Analytical Support and Sanctions Monitoring Team

Impact assessment of Security Council resolution 2347 (2017)

- 1 The Monitoring Team recommends that the Committee write to Member States to encourage those that have not yet done so to establish, with the assistance of the International Criminal Police Organization (INTERPOL), specialized police units dedicated to the protection of cultural heritage and investigations into cases of trafficking in cultural property. The Monitoring Team further recommends, in this context, the establishment of a national stolen works of art database directly connected to the corresponding INTERPOL database. In addition, the Monitoring Team recommends that the Committee write to Member States encouraging them to fund and support training workshops by INTERPOL on fighting the illicit trafficking in cultural property in key areas of the world.
- 2 The Monitoring Team recommends that the Committee write to Member States encouraging them to raise awareness among the relevant judicial and law enforcement agencies of the United Nations Educational, Scientific and Cultural Organization (UNESCO) training course regarding the illicit trafficking in cultural property, which is available at the UNESCO website.

Asset freeze

- 3 The Monitoring Team recommends that the Committee write to Member States to recall the request set out in paragraph 11 of resolution 2462 (2019) to make public their assets freezing actions under the relevant resolutions and to share such information with the Monitoring Team.

The Chair, on behalf of the Committee, will write to Member States to encourage those that have not yet done so to establish, with the assistance of INTERPOL and other Member States, as appropriate, specialized police units dedicated to the protection of cultural heritage and investigations into cases of trafficking in cultural property. In this context, Member States are also encouraged to establish a national stolen works of art database that is directly connected to the corresponding INTERPOL database and is interoperable with the INTERPOL database. In addition, the Chair, on behalf of the Committee, will write to Member States encouraging them to voluntarily fund and support training workshops by the United Nations Office on Drugs and Crime on fighting the illicit trafficking in cultural property in key areas of the world.

The Chair, on behalf of the Committee, will write to Member States encouraging them to raise awareness among the relevant judicial and law enforcement agencies of the UNESCO training course regarding the illicit trafficking in cultural property, which is available at the UNESCO website.

The Chair, on behalf of the Committee, will write to Member States to recall the request set out in paragraph 11 of resolution 2462 (2019) to make public their assets freezing actions under the relevant resolutions and to share such information with the Committee, including further consideration by the Monitoring Team.
