Security Council Committee established pursuant to resolution 1718 (2006)

Note verbale dated 11 February 2008 from the Permanent Mission of Luxembourg to the United Nations addressed to the Chairman of the Committee

The Permanent Mission of Luxembourg to the United Nations presents its compliments to the Chairman of the Security Council Committee established pursuant to resolution 1718 (2006) concerning the Democratic People's Republic of Korea and, pursuant to paragraph 11 of that resolution, has the honour to transmit herewith information regarding the implementation of the measures set forth in paragraph 8 of the resolution (see annex).

Luxembourg and the other States members of the European Union jointly implement the restrictive measures against the Democratic People's Republic of Korea referred to in Security Council resolution 1718 (2006) in accordance with Council Common Position 2006/795/CFSP of 20 November 2006 concerning restrictive measures against the Democratic People's Republic of Korea.

The national implementing provisions are set forth in the Grand Ducal Regulation of 19 October 2007 requiring licences for the export and transit of certain goods (luxury items) to the Democratic People's Republic of Korea (see annex).

Grand Ducal Regulation of 19 October 2007 requiring licences for the export and transit of certain goods (luxury items) to the Democratic People's Republic of Korea

Luxembourg Palace 19 October 2007

We Henri, Grand Duke of Luxembourg, Duke of Nassau,

Having regard to the amended Act of 5 August 1963 concerning the import, export and transit of goods and related technology;

Having regard to article 2 (1) of the Act of 12 July 1996 on reform of the Council of State and whereas exigent circumstances exist;

Having regard to Council Regulation (EC) No. 329/2007 concerning restrictive measures against the Democratic People's Republic of Korea;

Having regard to the Grand Ducal Regulation of 16 November 2000 concerning the general conditions for the operating and use of prior authorization for the import, export and transit of goods and related technology;

Whereas the aforementioned Council Regulation (EC) No. 329/2007 provides that it is prohibited to sell, supply, transfer or export, directly or indirectly, luxury goods to the Democratic People's Republic of Korea;

Based on the report of Our Minister of Economic Affairs and Foreign Trade, Our Minister for Foreign Affairs and Immigration and Our Minister of Finance and after deliberation of the Government in Council;

Hereby decide:

- **Art. 1.** The export and transit to the Democratic People's Republic of Korea of the goods listed in the annex, regardless of origin, shall be subject to the issuance of a licence.
- **Art. 2.** Our Minister of Economic Affairs and Foreign Trade, Our Minister for Foreign Affairs and Immigration and Our Minister of Finance shall be responsible for the implementation of this regulation, which will be published in the Official Journal.

- 2. Caviar and caviar substitutes
- 3. Truffles and preparations thereof
- 4. High-quality wines (including sparkling wines), spirits and spirituous beverages
