## Report of the Government of the Republic of Lithuania regarding the implementation of Security Council resolution 2094 (2013)

- 1. The framework for the implementation of international sanctions in the Republic of Lithuania was established by the Law on the Implementation of Economic and other International Sanctions (2004) (see http://www3.lrs.lt/pls/inter3/dokpaieska.showdoc\_1?p\_id=256251). The Ministry of Foreign Affairs coordinates the implementation of international sanctions in the Republic of Lithuania and provides natural and legal persons with information about the issues pertaining to the implementation of the international sanctions.
- 2. The international sanctions are imposed in accordance with the directly applicable regulations of the European Union and the resolutions of the Government of the Republic of Lithuania, which implements other legislation of the European Union, as well as resolutions of the United Nations Security Council and decisions of the Organization for Security and Cooperation in Europe.
- 3. Security Council resolution 2094 (2013), by which the Council imposed sanctions on the Democratic People's Republic of Korea, previous Security Council resolutions on this subject and additional sanctions imposed by the European Union are implemented through the legislation listed in the following table.
