**National report of the Kingdom of Morocco on the implementation of Security Council resolutions concerning the Democratic People's Republic of Korea**

The report of the Kingdom of Morocco on the implementation of Security Council resolutions 1718 (2006), 1874 (2009), 2087 (2013) and 2094 (2013) concerning the Democratic People's Republic of Korea is submitted in accordance with paragraph 10 of resolution 2087 (2013) and paragraph 25 of resolution 2094 (2013).

**I. Introduction**

The Kingdom of Morocco reaffirms its firm, unfailing and long-lasting commitment to non-proliferation and disarmament efforts.

The Kingdom of Morocco, which has signed and ratified all the multilateral instruments concerning weapons of mass destruction, maintains its commitment to general and complete disarmament, and to nuclear disarmament in particular.

The Kingdom of Morocco recalls that the non-proliferation regime is based on a delicate balance between the rights and obligations of States, a balance which should be preserved and strengthened through full compliance with these instruments.

The Kingdom of Morocco stresses that all States are free to explore and use space for peaceful purposes in compliance with international law and Security Council resolutions.

The Kingdom of Morocco remains convinced that this dialogue, including as part of the six-party talks, is the appropriate framework for resolving disputes, for restoring peace and security on the Korean Peninsula, and for continuing the process leading to the implementation of the Joint Declaration on the Denuclearization of the Korean Peninsula, which is vital for regional peace and security.

**II. Implementation of Security Council resolutions concerning the Democratic People's Republic of Korea**

The Kingdom of Morocco has taken all measures required in the relevant Security Council resolutions to ensure their implementation by the various Moroccan departments concerned (Ministry of Economic Affairs and Finance, Defence Administration, Ministry of the Interior, Ministry of External Trade, Ministry of Industry, Trade, Investment and the Digital Economy, Customs Administration, National Security, Bank Al-Maghrib, etc.).

The Ministry of Foreign Affairs and Cooperation has transmitted to the departments and institutions concerned all the texts of the Council's resolutions and all documents of the Security Council Committee established pursuant to resolution 1718 (2006), including the implementation assistance notice to assist Member States in carrying out their obligations under the relevant resolutions.

The Ministry has asked the different departments to ensure the implementation of the different provisions of these resolutions in their respective areas of

jurisdiction, in order to prevent any violation of the sanctions and to transmit any information on this matter to the Ministry.

On the regulatory front, the Kingdom of Morocco, with the assistance of the United States Department of Commerce and in cooperation with the European Union, is preparing draft legislation to establish an export-control regime for dual-use chemicals.

When the draft legislation is adopted, the Kingdom will have an export-control regime that meets international standards, in line with the commitments of Morocco to support international efforts to combat the proliferation of weapons of mass destruction.

The Kingdom of Morocco reaffirms its determination to cooperate with the Security Council Committee established pursuant to resolution 1718 (2006), in accordance with the relevant resolutions of the Council.

The Kingdom of Morocco will submit to the Committee any additional information available, where applicable.
