The Permanent Mission of the Republic of Senegal to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution [1718 \(2006\)](#) and has the honour to transmit herewith the report of Senegal on the implementation of the measures contained in resolutions [1718 \(2006\)](#), [1874 \(2009\)](#), [2094 \(2013\)](#), and [2270 \(2016\)](#) of the Security Council (see annex).

**Report of Senegal on the implementation of Security Council
resolutions [1718 \(2006\)](#), [1874 \(2009\)](#), [2094 \(2013\)](#) and [2270 \(2016\)](#)**

1. Arms-related measures

Senegal has ratified most international instruments on non-proliferation and disarmament.

As part of its implementation of the provisions of the various resolutions, our country does not have military or technical cooperation relations with the Democratic People's Republic of Korea.

Given the lack of bilateral military cooperation, no specific measures have been taken in respect of the questions in the checklist template from the Security Council Committee established pursuant to resolution [1718 \(2006\)](#) on the Democratic People's Republic of Korea.

As a result, Senegal has no contact with the Democratic People's Republic of Korea regarding the direct or indirect supply, sale or transfer of arms and related materiel.

The same applies to the procurement of arms and any related materiel, as well as nuclear, ballistic missile or other weapons of mass destruction-related items or technology.

Lastly, Senegal and the Democratic People's Republic of Korea do not have any agreements for hosting of trainers, advisers or other officials for the purpose of military-, paramilitary- or police-related training.

2. Measures relating to mineral resources

Regarding ores, Senegal does not purchase from, or supply to, the Democratic People's Republic of Korea any of the minerals mentioned in resolution [2270 \(2016\)](#).

With regard to legislation on mineral resources, Senegal has a body of laws that includes:

(a) Act No. 2003-36 of 24 November 2003 on the Mining Code, and implementing decree No. 2004-647 of 17 May 2004 setting out the arrangements for enforcing the Code.

(b) Ministerial order No. 09249/MEM/DMG of 14 June 2013 on the organization of gold-mining operations.

(c) Ministerial order No. 02472/MIM/DMG of 10 February 2014 on the definition of "gold-mining corridors" set aside for gold-mining operations in the regions of Tambacounda and Kédougou.

(d) Interministerial order No. 09931/MIM/DMG of 18 June 2014, setting out the arrangements for opening and operating marketing syndicates for precious metals and precious stones.

3. Measures relating to financial operations

There is no economic cooperation between Senegal and the Democratic People's Republic of Korea.

Consequently, the measures in the sanctions regime that are intended to prevent all financial transactions with the Democratic People's Republic of Korea and all transfers of technical training, advice, services (including brokerage or other intermediary services) or assistance to or from that country are not applicable in the case of Senegal.

The same applies to measures intended to prevent new commitments in the form of donations, financial assistance or concessional loans to the Democratic People's Republic of Korea.

4. Measures relating to entry into the national territory

Regarding measures relating to entry into or transit through Senegal, there are no direct commercial aviation links between Senegal and the Democratic People's Republic of Korea (see the table below).

As for the measure requiring nationals of Senegal and persons within its borders from leasing or chartering Senegalese-flagged vessels or aircraft to the Democratic People's Republic of Korea or providing crew services to that country, it should be noted that there are no contracts between the two countries involving the leasing or chartering of Senegalese aircraft or Senegalese crews.

It should also be noted that Senegal does not have a formal framework for cooperation with the Democratic People's Republic of Korea.

Furthermore, as a non-permanent member of the Security Council, Senegal abides by the resolutions of that organ and other United Nations bodies.

These measures shall not apply with respect to the sale or supply of aviation fuel to civilian passenger aircraft outside the DPRK exclusively for consumption during its flight to the DPRK and its return flight.

8(b) Prohibit their nationals and those in their territories from leasing or chartering their flagged vessels or aircraft or providing crew services to the DPRK? As called upon, de-register any vessel that is owned, operated or crewed by the DPRK; not register any such vessel that is de-registered by another Member State?

Senegal does not have any contracts with the Democratic People's Republic of Korea involving the leasing or chartering of Senegalese aircraft or crews.

This measure shall not apply with respect to such leasing, chartering or provision of crew services notified to the Committee in advance on a case-by-case basis accompanied by: (a) information demonstrating that such activities are exclusively for livelihood purposes which will not be used by DPRK individuals or entities to generate revenue, and (b) information on measures taken to prevent such activities from contributing to violations of the resolutions [1718 (2006), 1874 (2009), 2087 (2013), 2094 (2013) and 2270 (2016)].

8(d) Deny permission to any aircraft to take off from, land in or overfly Member States' territory unless under the condition of landing for inspection, if the State has information that provides reasonable grounds to believe that the aircraft contains prohibited items, except in the case of an emergency landing?
