## **Report regarding Ukraine's implementation of Security Council** resolution 2270 (2016)

Ukraine consistently pays particular attention to ensuring that Security Council resolutions are implemented and adheres strictly to their provisions.

On 16 May 2007, the Cabinet of Ministers of Ukraine adopted resolution No. 746, entitled "On implementation of the resolution of the United Nations Security Council on the Democratic People's Republic of Korea".

On 14 August 2014, Law No. 1644-VII, entitled "On sanctions", was adopted, which envisages, in article 3, subparagraph 1 (2), that resolutions of the Security Council are a basis for the application of sanctions by Ukraine.

Following the adoption by the Security Council of resolution 2270 (2016), the Ministry of Foreign Affairs of Ukraine promptly informed all State executive bodies concerned, as well as the National Bank of Ukraine, of the action that must be taken pursuant to Security Council resolution 2270 (2016).

Furthermore, the Ministry of Foreign Affairs of Ukraine prepared a draft order of the Cabinet of Ministers of Ukraine on the proposal for the application of sectoral, special economic and other restrictive measures, in accordance with Security Council resolution 2270 (2016) concerning the Democratic People's Republic of Korea. The document includes provisions on the implementation of Security Council resolution 2270 (2016) in all its aspects. The draft order is currently undergoing the requisite approval procedures, in line with the national legislation of Ukraine.

Ukraine intends to continue its close collaboration with the Security Council Committee established pursuant to resolution 1718 (2006) with the aim of fulfilling the requirements envisaged in resolution 2270 (2016). Following the approval and circulation by the Committee, on 25 May 2016, of implementation assistance notice No. 2 on guidelines on the preparation and submission of national implementation reports, together with the optional checklist template on measures contained in Security Council resolutions 1718 (2006), 1874 (2009), 2087 (2013), 2094 (2013) and 2270 (2016) relevant to Member States' national implementation reports, the said documents will be forwarded to the State bodies concerned for their consideration and preparation of the relevant information.
