**Report of Equatorial Guinea on the implementation of  
Security Council resolutions [2375 \(2017\)](#) and [2397 \(2017\)](#)**

The Government of the Republic of Equatorial Guinea, which has signed and ratified all multilateral instruments concerning weapons of mass destruction, remains committed to general and complete disarmament, in particular the nuclear disarmament of the Korean Peninsula. The Republic of Equatorial Guinea remains convinced that dialogue is the appropriate framework for the peaceful settlement of disputes and the restoration of peace and security on the Korean Peninsula, and supports the continuation of the process for the denuclearization of the Peninsula, which is fundamental to peace and security in the region pursuant to the Security Council resolutions on the Democratic People's Republic of Korea.

The Republic of Equatorial Guinea applies the restrictive measures imposed on the Democratic People's Republic of Korea by the Security Council Committee established pursuant to resolution [1718 \(2006\)](#) and has taken all the measures necessary to ensure their implementation by the various departments concerned. In this regard, the Republic of Equatorial Guinea wishes to reiterate its commitment to the implementation of the resolutions on the Democratic People's Republic of Korea, including resolutions [2375 \(2017\)](#) and [2397 \(2017\)](#), and to inform the Committee that, in order to prevent any violations of the sanctions and to do everything necessary to give effect to them, the Government of the Republic of Equatorial Guinea, in a communication sent by its Ministry of Foreign Affairs and Cooperation on 3 November 2017, informed the Embassy of the Democratic People's Republic of Korea accredited in Malabo of its decision that all companies of the Democratic People's Republic of Korea established in Equatorial Guinea should cease all commercial activities and urgently repatriate all citizens of the Democratic People's Republic of Korea, while the Government considered other arrangements and measures in that regard.

The Prime Minister of the Republic of Equatorial Guinea held a meeting with the Ambassador of the Democratic People's Republic of Korea, at which the latter was formally informed of the Government's decision of 3 November 2017.

The modalities for implementing the Government's decision are currently under consideration and possible legal implications are being carefully reviewed.

The Republic of Equatorial Guinea reaffirms its resolve to continue to cooperate with the Committee and, in compliance with the relevant resolutions of the Security Council, the Government of the Republic of Equatorial Guinea undertakes to keep the Committee apprised of any additional information that becomes available.
