**Report of Tunisia on the implementation of Security Council

Further to its initial report ([S/AC.49/2017/59](#)), and in accordance with paragraph 17 of resolution [2397 \(2017\)](#), the Government of the Republic of Tunisia wishes to reaffirm its commitment to taking the necessary measures to implement all Security Council resolutions concerning the Democratic People's Republic of Korea, including resolutions [1718 \(2006\)](#), [1874 \(2009\)](#), [2087 \(2013\)](#), [2094 \(2013\)](#), [2270 \(2016\)](#), [2321 \(2016\)](#), [2356 \(2017\)](#), [2371 \(2017\)](#), [2375 \(2017\)](#) and [2397 \(2017\)](#).

The Security Council resolutions on the Democratic People's Republic of Korea continue to be disseminated to the relevant national authorities, including banks and financial institutions, as they are adopted.

As part of the follow-up to the meeting of the Ministerial Council of 3 November 2017, a national commission has also been tasked with establishing a national mechanism to ensure the full implementation of United Nations sanctions against the proliferation of weapons of mass destruction and their financing, and the related recommendation of the Financial Action Task Force (FATF).

It should also be noted that Tunisia has not maintained economic relations with the Democratic People's Republic of Korea since the end of September 2017. Equally, Tunisia is unaware of any workers who are nationals of the Democratic People's Republic of Korea in its territory.

The competent bodies of the Ministry of National Defence continue to monitor maritime navigation in Tunisian waters, particularly focusing on vessels in transit that are flying the flag of or are operated by the Democratic People's Republic of Korea, and especially those that are on the blacklist. They verify the identity of and inspect the vessels, in coordination with the other competent national authorities.

Tunisia has also joined the Proliferation Security Initiative, which brings together 105 member States, thereby demonstrating its commitment to combating the proliferation of weapons of mass destruction.
