

Security Council Committee established pursuant to resolution 2127 (2013) concerning the Central African Republic

Note verbale dated 23 June 2014 from the Permanent Mission of Estonia to the United Nations addressed to the Chair of the Committee

The Permanent Mission of Estonia to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution 2127 (2013) concerning the Central African Republic and has the honour to refer to the note verbale dated 16 January 2014 and convey the following.

The Mission submits herewith the following report on the steps taken with a view to implementing effectively paragraph 54 (arms embargo) of resolution 2127 (2013) and paragraphs 30 (travel restrictions) and 32 (assets freeze) of resolution 2134 (2014).

Estonia implements the arms embargo pursuant to Council of the European Union Decision 2013/798/CFSP of 23 December 2013 concerning restrictive measures against the Central African Republic, as amended by Council Decision 2014/125/CFSP of 10 March 2014, and Council Common Position 2008/944/CFSP of 8 December 2008 defining common rules governing control of exports of military technology and equipment.


Administrative measures that prevent the prohibited actions have been enacted in Estonian legislation. The Strategic Goods Act establishes a strategic goods control system, regulating the transfer of strategic goods, provision of services related to strategic goods, control over import and end-use of strategic goods and implementation of supervision in all these fields.

The prohibitions deriving from the aforementioned legal acts do not apply to activities covered by the exemptions set out in resolutions 2127 (2013) and 2134 (2014).

Estonia implements travel restrictions pursuant to Council Decision 2014/125/CFSP of 10 March 2014 amending Decision 2013/798/CFSP concerning restrictive measures against the Central African Republic.

Administrative measures that prevent the entry into or transit through Estonian territory of the designated persons have been taken. The Government of the





Republic of Estonia has adopted governmental order No. 236 regarding the implementation of the restrictive measures imposed against the Central African Republic. Travel restrictions are implemented pursuant to the Obligation to Leave and Prohibition on Entry Act.

Estonia implements assets freezes pursuant to Council Decision 2014/125/CFSP of 10 March 2014 amending Decision 2013/798/CFSP concerning restrictive measures against the Central African Republic and in accordance with the Council Regulation (EU) No. 224/2014 of 10 March 2014 concerning restrictive measures in view of the situation in the Central African Republic.

Infringements of the restrictive measures imposed by international organizations are punished pursuant to the Penal Code of the Republic of Estonia.
