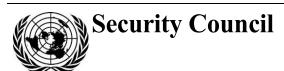

Security Council Committee established pursuant to resolution 2140 (2014)

The Permanent Mission of India to the United Nations has the honour to transmit herewith the report of India on the implementation of Security Council resolutions 2140 (2014) and 2216 (2015) (see annex).

Report of India on the implementation of Security Council resolutions 2140 (2014) and 2216 (2015)

The Government of India published an Order dated 21 September 2015 on the implementation of the Security Council resolutions on Yemen in the Gazette of India. ¹ The Order was published in order to incorporate into Indian domestic law the sanctions against Yemen established by the Security Council in its resolutions 2140 (2014) and 2216 (2015).

Arms embargo

The Order provides for the prevention of the direct or indirect supply, sale or transfer to, or for the benefit of, Ali Abdullah Saleh, Abdullah Yahya al Hakim, Abd al-Khaliq al-Huthi and the individuals or entities designated by the Committee established pursuant to paragraph 19 of resolution 2140 (2014) in accordance with paragraph 20 (d) of resolution 2216 (2015), the individuals and entities listed in the annex to resolution 2216 (2015), and those acting on their behalf or at their direction in Yemen, from or through Indian territories or by Indian nationals, or using Indian flag vessels or aircraft, of arms and related materiel of all types, including weapons and ammunition, military vehicles and equipment, paramilitary equipment and spare parts for the aforementioned, or the provision of technical assistance, training, financial or other assistance related to military activities or the provision, maintenance or use of any arms and related materiel, including the provision of armed mercenary personnel, whether or not they originate from Indian territories.

Travel ban

The Order prevents the entry into or transit through the territories of India of designated individuals. Exemptions are provided in accordance with the abovementioned resolutions.

Asset freeze

The Order provides for the freezing of all funds, other financial assets and economic resources that are on the territories of India and owned or controlled, directly or indirectly, by designated individuals or entities, or by individuals or entities acting on their behalf or at their direction, or by entities owned or controlled by them. It also provides for the prevention of any funds, financial assets or economic resources being made available by Indian nationals or by any individuals or entities within the territories of India, to or for the benefit of the designated individuals or entities. Exemptions are provided in accordance with the above-mentioned resolutions.
