

The Permanent Mission of the Republic of Kazakhstan to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution 2206 (2015) concerning South Sudan, and has the honour to transmit the National Action Plan of the Republic of Kazakhstan to implement Security Council resolution 2206 (2015) of 3 March 2015 (see annex).

## National Plan of Action of the Republic of Kazakhstan for the implementation of Security Council resolution 2206 (2015) of 3 March 2015

- 1. The Border Service of the National Security Committee and the Ministry of the Interior of the Republic of Kazakhstan shall take the necessary measures to prevent the entry into or transit through the territory of the Republic of Kazakhstan of any individuals designated by the sanctions Committee pursuant to paragraph 9 of resolution 2206 (2015), who represent a threat to the peace process or are complicit in, or have engaged in, directly or indirectly, actions or policies that threaten the peace, security or stability of South Sudan, provided that nothing in this paragraph shall oblige the Republic of Kazakhstan to refuse entry into its territory to its own nationals.
- 2. The Financial Monitoring Committee of the Ministry of Finance, the Ministry of the Interior and the National Security Committee of the Republic of Kazakhstan shall take the necessary measures to identify and freeze without delay all funds, other financial assets and economic resources that are on the territory of the Republic of Kazakhstan and are owned or controlled, directly or indirectly, by any individuals or entities included in the sanctions list or by any individuals or entities acting on their behalf or at their direction, or by entities referred to in paragraph 12 of resolution 2206 (2015) that are owned or controlled by them, and also to ensure that no funds or other assets shall be made available to them by nationals of the Republic of Kazakhstan or by any persons within the territory of the Republic of Kazakhstan.
- 3. The Ministry of Foreign Affairs of the Republic of Kazakhstan, with a view to adopting measures to prevent the entry into or transit through the territory of the Republic of Kazakhstan of any individuals designated by the aforementioned sanctions Committee in accordance with paragraph 9 of resolution 2206 (2015) and also to preventing the use of funds, other financial assets and economic resources by persons referred to in paragraph 12 of resolution 2206 (2015), shall promptly send to the relevant State agencies of the Republic of Kazakhstan any information concerning individuals (full family name, first name, patronymic, date of birth, nationality and passport number) and entities that, as established by the Security Council Committee, represent a threat to the peace process in South Sudan.
- 4. The National Security Committee, the State Revenue Committee of the Ministry of Finance and the Ministry of the Interior of the Republic of Kazakhstan shall report within twenty-four hours to the Ministry of Foreign Affairs of the Republic of Kazakhstan on all information discovered and action taken thereon under this Plan.
