Report of Myanmar on the implementation of Security Council resolutions [2375 \(2017\)](#) and [2397 \(2017\)](#)

1. Pursuant to paragraph 19 of Security Council resolution [2375 \(2017\)](#) and paragraph 17 of Security Council resolution [2397 \(2017\)](#), the Council has decided that Member States shall report to the Security Council on concrete measures they have taken in order to effectively implement the stated provisions. In this regard, the Myanmar hereby submits the report on the implementation measures for those resolutions as follows.

Overview

2. Myanmar is a strong advocate of nuclear disarmament, perceiving that nuclear disarmament and non-proliferation are interrelated and mutually reinforcing. With the firm conviction that weapons of mass destruction pose a serious threat to international peace and security, Myanmar has acceded to, ratified or signed the relevant international treaties on disarmament.

3. Myanmar has fully implemented its obligations under relevant Security Council resolutions and submitted its implementation report for the first time on 6 October 2017 pursuant to resolutions [2371 \(2017\)](#), [2321 \(2016\)](#) and [2270 \(2016\)](#).

Implementation measures

4. In addition to the information provided in the previous report on the implementation of Security Council resolutions relating to the Democratic People's Republic of Korea, Myanmar hereby reports additional measures taken by the Government of Myanmar for implementation of the provisions of resolutions [2375 \(2017\)](#) and [2397 \(2017\)](#), as follows:

(a) The Government of Myanmar has instructed all relevant ministries, agencies and regional governments to fully implement the provisions of both resolutions by issuing a presidential order dated 15 January 2018;

(b) The texts of resolutions [2375 \(2017\)](#) and [2397 \(2017\)](#) and the lists of individuals and entities subject to travel ban and/or asset freeze in the annexes I and II to those resolutions have been distributed to the relevant ministries, agencies and regional governments in order to include these individuals in a travel ban list and freeze their assets;

(c) In accordance with paragraph 18 of resolution [2375 \(2017\)](#) and paragraph 8 of resolution [2397 \(2017\)](#), a North Korean restaurant, which was run in Yangon, was instructed to close down and the stay permits for 21 nationals of the Democratic People's Republic of Korea working there were not allowed to get extended anymore. All of those nationals of the Democratic People's Republic of Korea left Myanmar on 25 March 2018.

Conclusion

5. Myanmar welcomes the inter-Korean summits and the two summits between the United States of America and the Democratic People's Republic of Korea in June 2018 and February 2019 and acknowledges the efforts to bring progress to the denuclearization process of the Korean Peninsula.

6. Myanmar is fully committed to the implementation of Security Council resolutions, including resolutions [2397 \(2017\)](#), [2375 \(2017\)](#), [2371 \(2017\)](#), [2321 \(2016\)](#) and [2270 \(2016\)](#), and supports efforts to resolve the issue of denuclearization on the Korean Peninsula in a peaceful and constructive manner.
